McReynolds was an Administrative Assistant to the President and Liaison Officer for Personnel Management under President Franklin D. Roosevelt from 1941 until Roosevelt's death. His duties brought him in contact with those agencies of the Federal government dealing with personnel and manpower problems and it is the correspondence with these agencies that constitutes most of this collection. Included in this material are the following: a notebook containing a daily record of persons who telephoned or came personally to the White House, July 21, 1941 - May 31. 1945; a report by the Occupational Analysis Section. United States Employment Service, March 6, 7, 1942; a file of executive orders pertaining to the Federal Civil Service and other material relating to the United States Civil Service Commission, 1941-42; a file of material from the War Manpower Commission, 1943, containing job descriptions, forms, and reports; a file of inter-office White House memoranda, releases of Federal departments, correspondence with McReynolds, and forms used to record personnel additions and changes in Government agencies; a file of personnel matters of the Treasury Department and its Procurement Divisions: a file of correspondence with the National Resources Planning Board; a file of executive orders, hearings, press releases, and other materials relating to pay and overtime work of Federal employees during the war years; a file of requests for deferments from military service made by Federal agencies on behalf of certain of their employees; a file of laws and correspondence relating to pay of Federal employees, 1943-1944; a file of correspondence with the National Resources Planning Board on postwar planning problems; a file of publications of the Office for Emergency Management relating to the training of manpower within industry; a file of correspondence with the Bureau of the Budget regarding individual personnel cases and some large-scale studies and reports on the subject of pay and other personnel problems; a file of War Department material consisting of executive orders, correspondence relating to utilization of manpower, and orders effecting wages and hours of work; a file on "Dollar-a-year" appointments consisting of correspondence with various agencies on policy matters, directives from the President, discussions of qualifications for these positions, and copies of several "Dollar-a-year" appointments signed by President Roosevelt. Also present are a file of correspondence of G. Lyle Belsley, assistant to McReynolds, consisting of letters exchanged with the United States Civil Service Commission and other Government and non-Government agencies on the subjects of Civil Service and public administration; and a file of speeches by Guy Moffett, consultant to McReynolds.
