INTRODUCTION

The Interdepartmental Committee to Coordinate Health and Welfare Activities was created in August 1935, following passage of the Social Security Act, in order that the full benefit of the varied Federal program under the Act's provisions might reach with minimum delay and maximum effectiveness the individual men, women, and children for whose aid and services the program was brought into existence. The Act imposed on the Federal agencies heavy responsibilities additional to those already existing in the health and welfare field. Because of the magnitude of these services and the wide distribution of administrative responsibilities for them among the Federal agencies, the need for unity of planning and program procedure was readily apparent.

As an approach to these problems, the Interdepartmental Committee was established by the President. As members of the committee he designated the assistant secretaries of the Departments of the Treasury, Interior, Agriculture, and Labor, and the chairman of the Social Security Board. In outlining the duties of the Committee, the President said in part:

"I am directing this Committee to include within the scope of its work not only health activities, but closely related welfare activities as well. As to its immediate task, I am instructing this Committee to assume responsibility for the appointment of special committees to be composed of physicians and other technically trained persons with the Government service to study and make recommendations concerning specific aspects of the Government's health activities.

"I am confident that this procedure will facilitate the consummation of a series of appropriate cooperative agreements between various departments of the Government. I am also hopeful that in this way we can eventually bring about a complete coordination of the Government's activities in the health field."

Later, in Executive Order 7481 issued by the President on October 27, 1936, the Committee's duties were outlined more definitely in the following terms:

"It shall be the duty of this Committee (1) to continue to sponsor appropriate cooperative working agreements among the various agencies of the Government in the health and welfare field, and to continue the work under agreements already in effect; and (2) to study and make recommendations concerning specific aspects of the health and welfare activities

of the Government, looking toward a more nearly complete coordination of the activities of the Government in these fields.

"The Committee will continue to function through the special technical committees it has set up from time to time, and will designate additional committees to deal with new problems."

The Interdepartmental Committee's first task was the setting up of technical committees to work out immediate cooperative agreements between Federal agencies functioning in similar fields in the States. The Interdepartmental Committee itself served as a board of review, and when agreement on technical considerations had been reached by a particular technical committee a memorandum of agreement was prepared, reviewed, and acted upon by the Interdepartmental Committee.

As the work of the Interdepartmental Committee progressed, the investigations of its staff revealed many subjects in which there was need of a coordinated approach to the solution of problems in the health and welfare field. Technical committees were created to consider coordination possibilities in the following fields: food and nutrition; public health nursing; industrial hygiene; crippled children; public health and safety education; recreational projects; the Indian medical service; workers' education; medical care; work with the needy blind; personnel standards in the Social Security Program in States; probation, parole, and crime prevention; transient and migratory problems; Federal-State relations; and medical care and public health services in the Resettlement Administration.

Miss Josephine Roche, Assistant Secretary of the Treasury, served as chairman of the Committee from its beginning. Though Miss Roche resigned from the Treasury Department in November 1937 to return to her business in Denver, she continued, at the request of the President, as chairman of the Interdepartmental Committee throughout its existence. The Committee called the National Health Conference, which lasted three days, July 18-20, and considered the recommendations of the Technical Committee on Medical Care. About two hundred delegates, representing farmers, labor, consumers, and the professions, discussed the Technical Committee's report and generally agreed with its conclusions and recommendations. As a result of these efforts, early in 1939 the Wagner Health Bill was introduced in Congress and later another bill for hospital construction was presented for Congressional action.

With the coming of war in Europe and the establishment of many new agencies to coordinate all phases of the National defense program, the Interdepartmental Committee ceased to function.

This inventory describes the records of the Interdepartmental Committee to Coordinate Health and Welfare Activities, amounting to 19 cubic feet. These records were accessioned by the National Archives from the Children's

Bureau and now constitute a part of Record Group 220, Records of Presidential Committees, Commissions, and Boards, in the National Archives. Some time before these records were accessioned by the National Archives the chairman of the Interdepartmental Committee turned them over to Miss Katherine Lenroot of the Children's Bureau of the Department of Labor, on the grounds that they would be of more use to that Bureau than to any other. When the Children's Bureau was transferred to the Federal Security Agency in 1946 the records were offered to the National Archives. The Committee records now in the custody of the National Archives, particularly those of its technical committees, appear to be fragments of more extensive files. These fragments have required arrangement and the disposal of a quantity of valueless material.
