Condolence Messages Received by Myron C. Taylor at Time of FDR's Death. April, 1945.

Messages sent and received by Taylor. Includes telegrams sent by him to President Truman, Mrs. Roosevelt, Harry Hopkins and others; condolence messages received by Mr. Taylor from officials of the Italian Government, the Italian Royal Family, the Allied Commission, diplomats to the Holy See, Church dignitaries, religious orders and organizations; a press release of Taylor's, April 13, 1945; and copies of prayers delivered in churches at Rome on the occasion of President Roosevelt's death.

Taylor sent this volume to Mrs. Roosevelt on June 28, 1956 and Mrs. Roosevelt forwarded the volume to this Library on January 23, 1957.
